Side Saddle Association Classical Ladies Side Saddle Qualifier
Mark / Result Sheet (Updated November 2023)

SHOW **DATE** **JUDGE**

Open to SSA Members and Non-Members, aged 18 and over on January 1st of the current year, riding side saddle, on horses exceeding 148cms (14.2hh). To be judged 25% conformation and action, 25% manners & way of going, 25% rider and 25% turnout of horse & rider, by a SHBGB, BSHA, BSPS, P(UK) or SSA Panel Judge. Judges may request a short show, but will not ride exhibits; horses will not be stripped. Traditional habits must be worn. Fancy Dress and Period Costumes NOT permitted. **N.B. Silk Hats may be worn at any time of the day for this Class UNLESS Safety hats are compulsory for ALL competitors in accordance with Show Rules. Judges are requested to use this Mark Sheet.**

The highest placed horse/rider combination qualifies for the Final to be held at this year's National Side Saddle Show. In the event of previous qualification, this may be passed down to fourth place. A special rosette *kindly sponsored* by a Mrs. T. Mitchell and Mr. L. Mitchell and the qualification card will be given to the qualifying combination at each show, this may not always be the winner; if the winner has already qualified the card may be passed down to fourth place.

Qualifying combinations are required to become Full Members of the SSA 21 days prior to the National Side Saddle Show to be eligible to compete in the Final.

The **4 highest placed** exhibits, **Mare or Gelding**, 4 years and over, **exceeding 148cm** (suitable to carry a side saddle and ridden by a lady) in the **SSA Classical Ladies Side Saddle Qualifying Classes** qualify for **BSHA Ladies Show Horse Championship**. Competitors must be a Member of the BSHA or the SSA, or purchase a Day Ticket from the BSHA office. (Note): *If the Qualifier takes place after the current year's National Side Saddle Show, SSA Classical Final qualification is carried forward to the following year's Show. Combinations qualifying after the current year's BSHA Championship Show qualification is carried forward to the following year's Show.*
