A registration fee of £5.00 is payable on joining, or on renewing membership after 31st March.

SUBSCRIPTIONS are due on 1st January annually or on joining. Membership is renewed automatically for Members paying their subscriptions by **direct debit** drawn on the first working day in January.

Any Membership Application received between 1st June and 1st October must be paid by cheque or Postal Order. If the Application is accompanied by a completed Direct Debit form for the following year, the £4.00 cheque administration levy will be waived.

Payment by cheque. If payment by cheque is preferred instead of direct debit, an additional administration levy of £4.00 is payable.

MEMBERSHIP TYPES AND SUMMARY OF BENEFITS

- * **LIFE MEMBERS AND FULL MEMBERS** receive all benefits and privileges of Membership including eligibility to receive Championship Points and S.S.A. rosettes in Equitation Qualifying Classes.
- * A **JUNIOR MEMBER** is a Member who is aged under sixteen on 1st January of the current year. A Junior Member must have attained their 5th birthday by 1st January of the current year in order to compete in S.S.A. affiliated classes and to be able to receive Championship Points and S.S.A. rosettes in Equitation Qualifying Classes. A Junior Member may not vote at General Meetings.
- * AN **ASSOCIATE MEMBER** receives the same benefits as a Full Member, but may not receive Championship Points and S.S.A. rosettes in Equitation Qualifying Classes.

PART-YEAR MEMBERSHIP 1st OCTOBER ONWARDS

New members joining after 1st October will not be required to renew their membership until 31st December of the following year.
